Your notice req-reg.

The Telangana Employees Association (Gurukulam) humbly submits few points for your kind perusal and necessary action. The association is very much thankful for your relentless efforts in uplifting the down trodden children to Everest heights. We congratulate the Gurukulam authorities for getting good result and a bunch full of IIT and medicine seats. We humble submit you the following requests for your kind consideration and methodical action.

1. The government has given relaxation in transfers wide reference G.O no 61 on dated 24.5.18. we the union members appeal to you to conduct the transfers as per the government order. We request you to follow certain relaxations for the benefit of the employees.
  - a) We request you employees are eagerly waiting for the transfer to conduct transfer counseling to all the Gurukulam employees as most of the employees working in the same place for many years.
  - b) We appeal to you that there are only 05 Gurukulam spouses working in tribal welfare institutions although they belong to same Department they are not working together due to different reasons. We request you to adjust them together in the same place irrespective of different zones or cadre. The authorities may consider them in girls institutions as the children may get parental affection and healthy support for the institution. If the teachers cannot be adjusted they may be accommodated nearest place.

- c) We request you to give relaxation to 2016 promotees i.e. JL ,PGT ,TGT n PD,PETs as there is only one month shortage for 2 years minimum service.
  - d) We solicit you to show 100% vacancies including newly sanctioned school and upgraded colleges. As there may be shortage staff in the new institutions.
  - e) We bring to your notice that to give feasibility to work in girls institutions for the male employees who have crossed 50years. Male employees can be a helping hand in the girls institutions.
2. We request you to give promotions to left over PGTs, TGTs and PETs as JLs, PGTs and PDs as there are still vacancies left over in new institutions.
  3. Hindi subject should be introduced in all the jr.colleges and in degree colleges as tribal children have an added advantage to learn the language easily.
  4. Change of nomenclature and pay scales for the posts of PETs as TGT in physical education and PDs as PGT in physical education and JL in physical education on par with the school education and higher education. One RSCO(REGIONAL COORDINATOR SPORTS OFFICER) and two DCSO(DISTIRICT COORDINATOR SPORTS OFFICER) special posts may be allotted to physical education department.
  5. Regularization of Art and Craft teachers working in Gurukulam institutions in the sanctioned posts.
  6. Notional increment and service to the regularized contract teachers in 2008 on par with other government departments TRANSCO,GENCO etc..
  7. Health cards to all the Gurukulam employees.
  8. we request to sanction 10 casual leaves / paper OD for the union office bearers (03members) whenever they meet the Secretary/Addl.Secretary.
  9. English language training for all the Gurukulam teachers.
  10. Second part-time JL for the mathematics lecturers as they have to teacher 4 papers i.e.,1A,1B,2A & 2B.

We the members of the Association are very much hopeful that the above mentioned issues may be sorted out positively with kind heart.
