Residential Educational Institutions- Guidelines on recruitment of Staff in General (Boys) Institutions and in Girls Institutions- Orders- Issued.

ORDER:

Government have increased the number of Residential Schools exclusively for Girls i.e., more than 50% of the Residential Schools are functioning in the State under the control of various Residential Educational Institutions Societies viz., Social Welfare/Tribal Welfare/ BC Welfare / Minorities Welfare / General. There is every need to recruit Women Staff in all cadres to run the institutions meant for Girls. Thus, a meeting has been held on 12.5.2016 by the Special Chief Secretary to Government, Education Department, with Principal Secretaries / Secretaries to Government of Welfare Departments and Secretaries of Residential Educational Societies to discuss the issue. After detailed discussions, the Officers have made their recommendations.

2. Government, after careful examination of the matter and keeping in view the aforesaid recommendations, hereby issue the following guidelines:-
 - (i) Women Staff shall only be recruited in all cadres of posts in the Schools / Institutions meant for Girls, in terms of sub-rule (3) of rule 22-A of Telangana State and Subordinate Service Rules, 1996;
 - (ii) the Schools / Institutions meant for Boys shall be treated as General Schools / Institutions and the posts in such Schools / Institutions shall be filled with men and women candidates, in terms of sub-rule (2) of rule 22-A of Telangana State and Subordinate Service Rules, 1996; and
 - (iii) separate rosters in each cadre shall be maintained for General (Boys) Schools / Institutions and for Girls Schools / Institutions, in accordance with sub-rules (2) and (3) of rule 22-A of Telangana State and Subordinate Service Rules, 1996, respectively.
3. The Departments of Secretariat concerned shall take necessary action to carry out suitable amendments, wherever necessary, to the relevant Byelaws / Special Rules / Service Regulations etc., as the case may be of the respective Residential Educational Societies, under their administrative control.
