With reference to subject cited above, we modestly submit the following few lines for your kind consideration and methodical action.

Sir, we regret to inform you that some of the staff members have been working more than 20 years in the same cadre and some of them had already retired from their services after waiting a long period in distress for promotions. The Principals of Jr. Colleges and JLs come under zonal category and it is resolved in the 12<sup>th</sup> BOG in 2007. It is a known fact that the work can be extracted detrimentally from the Employees when they are catered the benefits they are deserved for. So we prospect the zonal wise promotions in all the cadres under your remarkable administration within days to curtail the deface caused by the delay in promotions in order to enliven them to work bountifully.

Sir, the staffs working in Tribal Welfare Residential School/Colleges have been striving hard to uplift the Tribal Students and to stimulate their innate abilities, attending round the

clock duties while discharging various duties apart from their regular academic work. Working in Govt. Schools and Colleges is totally different from working in Tribal Residential Institutions located in nook and corner places. As an upright personality, you know the pros and cons of the nature of work in residential system. So we feel it may not be a misdeed requesting for special Scales rather than corresponding scales of PRC-2015. Being experienced, you can understand that we need special scales and it should be implemented at your earliest convenience.


Accordingly, we would like to bring the iniquity that has done to PDs and PETs working in Schools and Colleges. They are getting ignoble wages while comparing with PGTs and TGTs and their names are not included in the common seniority list. So it is requested to equalize the salaries of PETs with TGTs and School PDs with PGTs and their names should be included in the common seniority list so that their names can also be ruminated for promotions for the post of Principals.

Finally, the problem of Part Time Teachers / Jls is brought to your kind notice on humanitarian grounds. They used to get Rs. 6,500/- PM and it is mitigated to Rs.5,000/e PM 2 year back. Being Post Graduates besides possessing B Ed degrees, their wages are less than a skilled daily wage worker who earns approximately Rs.10,000/- PM. A letter had already submitted to Honorable Minister and Chairman, Tribal Welfare Department to enhance their Salaries to Rs.16,000/- PM at School level and Rs.18,000/- PM at College level. We also request you to regularize the services of Art & Craft Teachers who have been rendering their services to the needy Tribal Students for 11 Years.

So, we request you candidly to look in to the above burning problems and we hope the rapid solutions may be found under your proficient administration.
