#### **ORDER:**

### Functions of the Board:

## The functions of the Board are as given below:

- i. To take up recruitment of Academic and non-Academic recruitment personnel of all Societies.
- ii. To revise Service Rules & Bye-laws and Standing Orders of all the Societies in order to bring them to a common platform.
- iii. To prescribe minimum Qualifications for each post in line with NCTE / other advisory bodies.
- v. The board may consult any expert including the School Education / Intermediate Education / Collegiate Education Department for any inputs.
- v. Any other function as assigned by the State Government.
